As a continued effort to beautify our wonderful neighborhood, the board would like to bring a few issues to everyone's attention. We live in one of the most beautiful neighborhoods in all of Syracuse and Central New York. We take pride in Sedgwick and it is our responsibility to keep it beautiful. That being said, we would like to address some potential concerns.

• Many of us get out to walk our dogs and during the cold winter months, snow often can build up. This can make things difficult at times due to unshoveled sidewalks. Please take the time to clear a path so that we all can enjoy ourselves without walking in the streets which is dangerous for walkers and drivers. In addition, please carry a plastic bag with you to clean up after your pet.

• In Sedgwick, trash pick up is on Tuesday mornings. Please put your trash out no earlier than the night before and take the empty trashcans back after pickup that same day.
